



# Welcome to New Baden

## Founded 1855

New Baden is rural community located on the western edge of Clinton County, about 27 miles east of St. Louis, Missouri. A small portion of New Baden is also located on the eastern edge of St. Clair County. Illinois State Route 160 passes north and south through the Village intersecting with Illinois State Route 161, which intersects Interstate 64 to the west. The population is approximately 3,349 (2010 Census).

### VILLAGE GOVERNMENT

The Village of New Baden has a Village President (Mayor) and six Trustees elected at large. Each Trustee and the Mayor are elected for a staggered term of four years. The terms of office are staggered so three Trustees are elected every two years. Village Board meetings are held the first Monday of each month, unless a holiday such meeting is held the following day, at 7:00 p.m. at the Village Hall. Committee-at-Large Meetings are held the 3<sup>rd</sup> Monday of each month, unless a holiday such meeting is held the following day, at 7:00 p.m. at the Village Hall. All meetings are open to the public.

An applicant for utility service, water and sewer, shall deposit a fee of \$100.00. Bills shall be due and payable on or before the 15<sup>th</sup> of the month. Unpaid bills at this time shall be considered delinquent and a 10% penalty will be assessed. Failure to make payment can result in disconnection of service. In the event this occurs, a reconnection fee of \$25.00 will be assessed and service restored only after full payment of debt. A night deposit drop box is available for payment (located on west side of Village Hall).

Billing for water and sewer is combined on one monthly bill, payable at Village Hall. Bills can be paid by check, cash or money order. The Village **does not** accept credit cards. An additional option is auto-deduct; the Village will withdraw the amount due from a checking or savings account on the 10<sup>th</sup> day of every month. Each residence within the corporate limits of New Baden is provided with a 95-gallon receptacle. Garbage collection is every Tuesday.

**RECYCLING COLLECTION:** Contracted through Republic Services. Mandatory through contract for New Baden residents. Each residence within the corporate limits of New Baden is provided with a 95-gallon receptacle. Collection is every other Tuesday; contact Village Hall for recycling schedule.

- **Acceptable Paper Products:** Corrugated Cardboard (please break down and tie w/twine and set next to recycling bin), Mixed Office Paper, Junk Mail, Newspaper & Gift Wrap, Chipboard (cereal boxes, soda cases, etc.), Magazines, Catalogs, Telephone & Paperback Books.
- **Acceptable Containers:** Aluminum & Tin Cans, Glass Bottles (Green, Amber, Clear), Plastic Bottles (with #1, 2, 3, 4, 5 & 7 in the recycle symbol), Colored HDPE (Detergent Bottles, Bleach Bottles, etc.). Please remove caps from milk, detergent and soda bottles. Please rinse all bottles and cans. Place them loose in the recycling bin.

**VILLAGE LAWS, ORDINANCES,  
REGULATIONS AND MISCELLANEOUS INFORMATION**

**ZONING:** Building Permits are required for new construction, buildings, structures, or major new accessory uses, and minor modifications and repairs to existing building/property (i.e. porches, decks, fences, utility sheds less than 160 square feet, above-ground swimming pools, roofs, dumpsters, and portable storage containers.

An Occupancy Permit is required whenever occupancy is established or changed in a residential structure. The fee for the Occupancy Permit Inspection is \$50.00. Applicants shall receive one (1) re-inspection at a rate of \$25.00. The fee for any subsequent inspections shall be equal to the original permit fee. **If property is occupied before a permit is issued the inspection fee will be \$100.00 and one (1) re-inspection fee of \$50.00. The fee for any subsequent inspections shall be equal to the original permit fee.** This fee must be paid prior to the inspection at Village Hall or at the time of the inspection. Contact the Chief Building & Zoning Official to set up your inspection appointment. This includes all homes, mobile homes, apartments, etc. Contact Village Hall for more details. **STREETS:** A special permit must be secured in order to construct or repair any street, sidewalk or alley. All persons using Village streets are expressly prohibited from parking where signs are posted and where it would be dangerous to the public.

**PEDDLERS/SOLICITORS:** All persons peddling and/or soliciting in the Village shall register at the Clerk's office. A daily license is \$25.00 per person and an annual license is \$100.00. Hours are from 10:00 a.m. to 5:00 p.m. No soliciting on Sundays or holidays.

**BUSINESS LICENSE:** All persons, companies, corporations, etc. engaged in any business or occupation from a location within the Village limits of the Village of New Baden are required to obtain a license to operate such business. An annual fee of \$25.00 is required per license. Said license is valid from May 1 to April 30 of the following year. Applications are available at Village Hall.

**BURNING OF LEAVES:** It is unlawful to burn leaves within the corporate limits of the Village.

**CURFEW TIME:** The local curfew for minors shall be 12:00 midnight on Friday and Saturday and 11:00 p.m. Sunday through Thursday.


