HMG and Rhutasel & Assoc. have both reviewed the issue and reached the same conclusions. Brian Buchheit of Henry, Meisenheimer, & Gende (Village Engineers) was in attendance and asked a few questions. He recommends having Public Works Commissioner Ron Renth get involved with the process. Original plans need to be reviewed and a Public Works Committee meeting will be scheduled.

## TIF Request: Ahner Florists and Greenhouse

Ted and Dawn Ahner of Ahner Florists and Greenhouse, 415 West Hanover Street, have submitted a TIF request for the installation of a concrete pad and a monosloped roof to be attached to the front of the greenhouse. Keith Moran, Moran Economic Development, reviewed the plan and recommended a 100% reimbursement of TIF eligible expenses, approximately \$6,400.00. Since his review, total costs have increased to about \$15,000.00 from an original \$13,000.00.
