Brant Kehrer Business Project

Brant Kehrer, owner of 115-123 E Hanover St, addressed to the Village Board his plans to have 119 E Hanover St converted to a restaurant/tavern featuring craft beers and appetizers. He has had discussions with Administrator Hemmer regarding his plans. Such a business will require a "Tavern" or "Restaurant" liquor license; depending on how much food service is expected to be provided. Mr. Kehrer also plans to apply for a video gaming license; Mr. Hemmer has made him aware of recent changes to the Village code requiring no more than 50% of revenue being derived from video gaming. Mr. Kehrer's attendance is to gather the Board's thoughts and get a feeling for their desire to expand the number of the required liquor license, allowing him to apply. The main concern of all Trustee's is the parking situation. Chief Building & Zoning Official Green stated that off-street parking is determined by the usable space of the proposed establishment. Mr. Green will discuss with Mr. Kehrer to determine what will meet his needs. The consensus of all Board members was to agree to the issuance of a liquor license to Mr. Kehrer, with an agreed upon parking situation. Village Board members reviewed the minutes of the March 8 Finance Committee meeting. This was final meeting discussing the Fiscal Year 2018-2019 Budget.

Franchise Agreement
