It shall be the owner/contractor's responsibility to notify all utilities and obtain disconnection dates. All utilities must be abandoned and protected in accordance with the requirements of the respective utility company **PRIOR** to the issuance of this permit.

All adjoining property owners must be notified prior to the beginning of demolition.

During the proposed demolition, it shall be the contractor/owner's responsibility to maintain the site in a safe and sanitary condition.

Any buried LP gas or fuel oil storage tanks must be removed. Septic tanks must be removed, filled in or collapsed.

Sewer and water lines must be terminated at the property line or in a location approved by the Village Department of Public Works.

Wells must be plugged by a licensed well driller. All demolition debris must be removed from the site, disposed of in an approved landfill, and be in compliance with all Federal, State, County and Village regulations.

Foundations must be removed

Upon completion of demolition, it shall be the contractor/owner's responsibility to fill and grade the lot to conform with established street grades, and adjoining property. Provisions shall be made to avoid the accumulation of water, rubbish, and all other unsafe and hazardous conditions.
