APPENDIX A

\* All distances are in linear feet unless otherwise stated.

\*\* When abutting a "SR" or "MR" district or lot, a side yard of fifteen (15) feet is required. When abutting a "SR" or "MR" district, a landscape screen of at least ten (ten) feet in depth and expected to reach a height of at least ten (10) feet shall be provided.

\*\*\* When existing building(s) in these districts have already established a building line a depth less than required, then all new buildings may conform to the same building line, except for a first fifty (50) feet of the district frontage adjacent to a Residential District, whereupon there shall be provided a front yard of not less than twenty-five (25) feet. When a commercial building in this specific district does not exist, and the lot adjoins a County/State/Federal highway, the front lot line of all new commercial buildings shall as a minimum, be aligned with the nearest commercial building regardless of district, or have a 75 foot setback, whichever is greater.
